## NOTICE

Dear Parents/Guardians,

In terms of the Order dated 13.10.2020 passed by Hon'ble High Court, Calcutta in WPA No. 5890/2020 read with Order dated 28.10.2020 of the Hon'ble Supreme Court in Special Leave Petitions filed against the said Order, which is pending, *inter alia* ordering that certain directions contained in the Order of Hon'ble High Court not to be implemented, the following information are given to you:

1. Pending a final adjudication of the appeals of the Hon'ble Supreme Court and in compliance of the remaining directions contained in the Order dated 13.10.2020 of the Hon'ble High Court, this **Notice** is been published for information and necessary action of the parents/guardians. Kindly bear whatever is being stated below is without prejudice to the rights and the contentions of the School and its Management in the pending proceedings in the Hon'ble Supreme Court, if any.
2. Substantial numbers of parents of students have already paid 100 percent of school fees and session fees for which the school is very grateful and it has helped the school to run and meet its various financial commitments in time of crisis.
3. We would like to highlight the remarks of the Hon'ble High Court from its Order stating that '**Parents & Guardians of students are requested not to avail of the reduction in school fees, if their financial situation does not permit the reduction**'.
4. Thus in terms of the direction of the Hon'ble High Court, we request parents who are financially capable to consider and not to avail such reduction and continue to pay 100% of fees for helping the school to run uninterruptedly.
5. Accordingly parents/guardian who have paid 100% of tuition fees as on date of this Notice and/or continue paying 100% of such tuition fees and/or intend to pay 100% of session fees are requested to continue doing so.
6. Parents and Guardians of the students of School are in terms of the Order dated 13.10.2020 of the Hon'ble High Court are now informed that they may opt to pay reduce fees in terms of clause no. 7 below.

8. In the event, parents who have paid 100% of tuition fees or session fees or other fees wish to avail reduction as mentioned above, they will not receive any refund but will have the amounts paid beyond the amount of reduce fees adjusted against payment of tuition fees for the subsequent period during the financial year ending March 2021, subject to their agreeing otherwise, for which intimation will be given by the School later, and further subject to the outcome of the appeal before the Hon'ble Supreme Court.
9. For those parents who opt to avail of the reduction in fees as stated in clause no. 7 above, the fees for the period commencing from 01.04.2020 to 30.11.2020 will have to be paid by 30.11.2020.
10. The fees prescribed in clause no. 7 above for the period commencing from 01.04.2020 to 30.11.2020 will have to be tendered by November 30<sup>th</sup>, 2020.
11. Fees payable by students to Boards for Examinations or otherwise shall have to be paid in additions to the monthly fees and other charges and no waiver or reduction of fees or charges is applicable on the same.
12. In the event, the fee stated above are not paid by 30.11.2020 with or without availing of reduction, in terms of the Order of the Hon'ble High Court, parents are informed that as per the said Order the concerned student will not be entitled to attend School in any mode and will be denied all facilities been offered by the School with effect from 08.12.2020. The Orders of the Hon'ble High Court Calcutta and Hon'ble Supreme Court are available on their respective websites and the parents/guardians are requested to access the same for their own understanding.
13. No student will be entitled to apply for a Transfer Certificate without payment of the full quantum of fees in terms of the said Order of the Hon'ble High Court.
14. The parents/guardians are informed that the Hon'ble High Court Calcutta has also directed in paragraph number 61(iv) of the Order dated 13.10.2020 that losses made by the Schools, **which will substantial in our case**, can be made up in the next two upcoming financial years.
15. All parents/guardians who wish to avail of the reduction of 20% in tuition fees and/or session fees as stated above may choose the option, whose details for payment of reduce fees shall be informed to you, post 25.11.2020.
